



Arnside & Silverdale National Landscape Grants Fund Guidance notes



**Arnside &
Silverdale
National
Landscape**

The Arnside & Silverdale National Landscape Grants Fund is run by Arnside & Silverdale National Landscape Partnership and the Arnside/Silverdale Landscape Trust¹, working together. Grants provide funds of up to £4000 to enable projects which conserve and enhance the National Landscape or connect people with the landscape.

Criteria

In order to be eligible for a grant, your project must:

- be located within, or demonstrate clear links to the Arnside & Silverdale National Landscape;
- conserve and enhance the National Landscape and/or enable people to connect with the landscape;
- *not* be a commercial or profit making project;
- be a capital investment; or revenue costs (e.g. staff costs) where these are directly linked to carrying out activities detailed in the application;
- contribute to the delivery of the Arnside & Silverdale National Landscape Management Plan ([downloadable from the National Landscape website](#));
- be consistent with the constitution of the Arnside/Silverdale Landscape Trust (Appendix 1); and
- demonstrate clear public benefit (e.g. public access or engagement).

We encourage projects that:

- Protect the flora and fauna of the Arnside & Silverdale National Landscape
- Restore, enhance or create wildlife habitat or benefit priority species
- Enhance, restore and improve understanding of ecological networks
- Improve or enhance the coast or seascape
- Restore cultural or historic features or assets
- Develop the National Landscape as a sustainable tourism destination
- Improve opportunities for people to access and enjoy the area, especially for those who may not otherwise have the opportunity to do so
- Promote inclusivity, and benefit diverse audiences
- Promote greater understanding of the area and encourage appropriate recreational opportunities
- Research, interpret, celebrate or raise awareness of the special qualities of the area; its nature, history or culture
- Connect and engage people (particularly young people and children) with the landscape
- Promote participation in traditional rural skills

- Involve the local community or volunteers
- Support local communities in moving towards sustainable low carbon living

We will not fund:

- Projects that are eligible for total funding through Countryside Stewardship or the Farming in Protected Landscapes programme.
- Core operational costs (e.g. rent or salaries)
- Commercial activities or projects where there is the likelihood of profit or financial reward for those managing the project
- Projects that do not demonstrate clear public benefit (e.g. public access or engagement)
- Projects that commence before an offer of a grant is made by the Grants Panel
- Repeat or annual applications for the same project unless in exceptional circumstances or where there has been a significant change in circumstances – please speak to National Landscape staff before preparing an application if you think this relates to your project

Who can apply?

- Community groups
- Schools
- Businesses
- Partner organisations
- Parish councils
- Landowners and managers
- Individuals

Applicants must have a bank account and, if you are a community group or charity, formal terms of reference describing the purpose, scope and authority of your organisation.

We strongly advise you to contact National Landscape staff before you apply so that support and guidance can be provided for the application process. Please note: project approval decisions are made by the Grants Panel; National Landscape staff support and guidance does not guarantee approval of an application.

How we assess your application

The final decision to award a grant is given by the Arnsdale & Silverdale National Landscape Grants Panel, which comprises nominated representatives from the National Landscape Partnership/team and the Landscape Trust who may in certain circumstances take advice from specific professional experts. For applications under £200, responsibility for approval of the application is delegated to the nominated representative of the Arnsdale/Silverdale Landscape Trust and the National Landscape Manager. The decision of the Panel or the nominated representatives is final.

Grants

- grant awards will normally be in the range of £100-£4000
- having match funding, or in-kind voluntary support in place is not essential, but will increase your chance of a successful application (see guidelines on how to calculate the value of volunteer time).
- in exceptional circumstances an award of over £4000 may be made to an applicant

- in all cases a Grant Agreement setting out what is required for satisfactory completion of the project will be signed prior to receipt of any monies
- grant payments will normally be staged as follows but this may be varied at the discretion of the Grants Panel
 - 50% of grant is paid on commencement of the project
 - 50% of grant is paid on successful completion of the project
- All successful applicants will be expected to provide a written report on completion of the project supported by receipted invoices and a photographic record – with relevant permissions given for use in National Landscape Partnership and Landscape Trust publicity and for circulation to the media. For larger or longer-term grants, reports will also be required at key milestone points to be agreed between the applicant and the Grants Panel when the grant is approved and also one year after the project is completed to allow longer term impact of the project to be monitored.
- The Grants Panel reserve the right to reclaim grant monies if the project is not carried out as agreed.

Appendix 1 – Arnside/Silverdale Landscape Trust Constitution

“To work for the public benefit of both residents and visitors within the Arnside/Silverdale Area of Outstanding Natural Beauty by stimulating and encouraging both understanding and active involvement in the protection, conservation and practical improvement of features of general public amenity or historical interest within the landscape.”
